CLASSY 100'S "MICHELOB ULTRA PATIO PARTY #6" CONTEST OFFICIAL RULES

The Station will conduct the **Classy 100's "Michelob Ultra Patio Party #6"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. Contest Period. The Contest entry period will begin at 4pm ET on Thursday, August 8th, 2024 and end at 7pm ET Thursday, August 8th, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** <u>Remote Broadcast</u>: Attend a remote broadcast conducted by Station on Thursday, August 8th, 2024 from 4pm-7pm at Oliver's Beer Garden (130 E. Front St. Erie, PA 16507), complete an entry form, and be present for the selection drawing at or about 7pm at remote venue. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. **Winner Selection.** At or about 7:01pm ET on Thursday, August 8th, 2024, Station will select 5 potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Prizes will be awarded subject to verification of eligibility and compliance with the terms of these rules. Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
