## WXKC-FM'S "CLASSY 100'S CHRISTMAS CATALOG" CONTEST OFFICIAL RULES

**Eligibility.** This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more. In the event of a dispute as to any registration, the authorized account holder of the telephone number used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the

wireless carrier or by an Internet access provider, online service provider or other organization responsible for assigning the telephone number. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

# Winner Selection.
